A Special Meeting of the East Nottingham Township Board of Supervisors was held in the Township Building on November 29, 2004. Those present were: Chairman Samuel A. Goodley Jr., Vice-Chairman Thomas J. Olivieri, Supervisor Charles Shelton, Secretary Pat Brady and numerous guests.

Chairman Goodley called the meeting to order at 8:50 P.M..

The Pledge of Allegiance was led by Vice-Chairman Olivieri.

Motion made by Chairman Goodley seconded by Vice-Chairman Olivieri to approve the agenda for the meeting.

Public Comment on Agenda- None

Consideration of Open Space Referendum Ordinance- Ordinance was approved by the voters. Motion made by Chairman Goodley seconded by Vice-Chairman Olivieri to authorize the Solicitor to advertise our Ordinance at a ½ of a percent, which is the maximum earned income tax increase authorized by the taxpayers referendum.

Oxford Area Recreation Authority- Lee Towner, Chairman requests a waiver from Article III from the Land Development Plan, so that they may install two temporary 20-25 car parking lots, made of road millings so that cars can park without sinking into the mud.

Motion made by Vice-Chairman Olivieri seconded by Supervisor Shelton to grant a waiver on Article III

*Chairman Goodley announced that the Board of Supervisors had executive sessions to interview for Zoning, Code Enforcement, Subdivision / Plan Development and Township Manager positions.

*Solicitor Sebastian asked when the Board of Supervisors wanted to adopt the Ordinance. Chairman Goodley responded January 3, 2005.

P.J. Scheese- Vice-Chairman Olivieri stated that the Township has hired P.J. for the month to train for different positions and help the Secretary. After that time, the Supervisors will decide if there is a future between us.


Recognition of Visitors-

Joe England- has questions about Open Space and would like the Supervisors to have a meeting that spells out what Open Space is. Vice-Chairman Olivieri stated that the money stays in East Nottingham Township and there are 23 other Townships involved with Open Space.


*Vice-Chairman Olivieri stated that he would like the Newsletter to ask the residents if East Nottingham Township should have their own Post Office or remain at Oxford?


Motion made by Chairman Goodley seconded by Vice-Chairman Olivieri to adjourn the meeting at 9:15 P.M..


