**RESOLUTION NO. 35 - 2006**

**A RESOLUTION EVIDENCING THE APPROVAL OF MINUTES OF MEETINGS OF  
THE EAST NOTTINGHAM TOWNSHIP BOARD OF SUPERVISORS HELD ON  
OCTOBER 24, 2005 AND OCTOBER 26, 2005**

WHEREAS, the Township of East Nottingham Township is required, as a matter of law under the Pennsylvania Second Class Township Code and the Sunshine Act to record and retain minutes of all public meetings of the Board of Supervisors; and

WHEREAS, the Board of Supervisors of East Nottingham Township desires to record and retain minutes of such public meetings both as a requisite of law and to keep and maintain consistent and accurate records of the business conducted and action taken at its public meetings; and

WHEREAS, it has been determined, through a review of the records of East Nottingham Township, that the Township records, and specifically, that record book which contains copies of meeting minutes of the meetings of the Board of Supervisors signed by the Board of Supervisors, is lacking in signed copies of minutes for meetings held on October 24 and October 26, 2005; and

WHEREAS, although the aforesaid record book is lacking signed copies of the minutes, nevertheless, the minutes for each of the meetings were posted on the official East Nottingham Township website; and

WHEREAS, it has been the practice of the Township Supervisors, and was, at the time of the meetings in question, to approve the minutes of all Board of Supervisors meetings at the next following meeting, to then sign the minutes, only then making the minutes available for posting on the Township website; and

WHEREAS, it has been determined that there are no circumstances under which meeting minutes were or are posted on the Township website until after approval; and

WHEREAS, based on the policy and procedure existing in October, 2005, and the fact that the meeting minutes were posted on the Township website, thereby publishing them as the approved meeting minutes for the meetings held on October 24 and October 26, 2005, the present Board of Supervisors has determined that the unsigned meeting minutes posted on the Township website constitute the record of the proceedings and actions taken at the two meetings, respectively; and


WHEREAS, there are no circumstances or evidence to indicate the contrary or that the lack of signed meeting minutes is other than inadvertent.


NOW, THEREFORE, based on the foregoing, be it resolved by the Board of Supervisors of East Nottingham Township as follows:

1. The attached meeting minutes for the meetings of the East Nottingham Township Board of Supervisors held on October 24, 2005 and October 26, 2005, being true and accurate copies of the meeting minutes posted on the official Township website for those two dates, shall constitute the record of proceedings and actions taken at the two meetings for all purposes.
2. A copy of this Resolution shall be included in the Township meeting minutes record along with the meeting minutes for October 24, 2005 and October 26, 2005.
3. This Resolution shall become effective immediately.
4. In the event any provisions, section, sentence, clause or part of this Resolution shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Resolution, it being the intent of the Board of Supervisors of East Nottingham Township that such remainder shall be and remain in full force and effect.
5. All resolutions or parts of resolutions inconsistent herewith are expressly repealed.
