November 21, 2005 at 7:00 P.M. to discuss the Jean Lawrie Parker Subdivision and any other bills that may come before the Board.

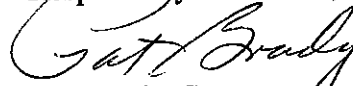

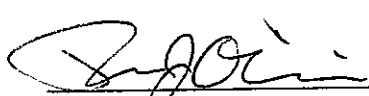

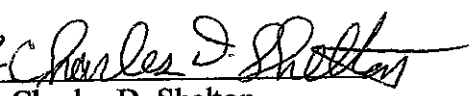
