

**MINUTES
EAST NOTTINGHAM TOWNSHIP
BOARD OF SUPERVISORS
REGULAR MEETING
JANUARY 2, 2007**

The Regular Meeting of the Board of Supervisors of East Nottingham Township was held in the Township Building on January 2, 2007. Those present were: Chairman Leo M. Levandowski, Vice-Chairman Michael P. Miller, Supervisor Charles D. Shelton, Supervisor Percy Reynolds, Supervisor Gene Turns, Treasurer Suzie Hamlin, Zoning Officer P.J. Scheese, Secretary Pat Brady and numerous guests.

The Meeting was called to order at 7:40 P.M..

The Pledge of Allegiance was led by Vice-Chairman Miller.

Approve Agenda- Motion made by Vice-Chairman Miller seconded by Supervisor Shelton to approve the agenda as presented by the Secretary.

Executive Sessions- Chairman Levandowski stated there was an Executive Session on December 20, 2006 with Dave Shelton, Pat Brady, Gene Turns, Percy Reynolds to discuss the agenda for the Organizational Meeting.

Minutes for Review- Chairman Levandowski stated there are copies of the Minutes from the BOS Regular Meeting for 12/12/06 on the table for review. They will be approved after the Supervisors section of the agenda.

Treasurer's Report- Suzie Hamlin read the report stating that East Nottingham Township's cash assets amount to \$2,586,796.34. Bills totaling \$101,824.65 for December 12, 2006 and December 28, 2006 were presented for payment from the General Fund. Income received for December 2006 total \$176,503.02 realized from taxes, escrow, court fines, permits, inspection fees, fire hydrant reimbursement and miscellaneous fees. General Fund balance as of 12/31/06 is \$146,940.73.

Road Report- Vice-Chairman Miller had questions for the Road Master concerning the progress on the red light at Happy Harry's, stating that they will continue until the weather stops them. Chairman Levandowski asked Road Master Bill Weaver about the

marks on the ground on Shadyside Road by the bend at the Shepherd property. Bill stated that's from PA One Call, not the Township. Supervisor Turns asked about the black top on Little Elk Creek Road. Bill stated we have not received a report yet and we haven't heard anything to date.

Zoning Report- P.J. Scheese gave her report.

Police Study Committee- Gerry Christians stated they had given the Supervisors information back in March and will gladly answer any questions they may have. Vice-Chairman Miller had several questions for Gerry Christians concerning East Nottingham Township crime.
