

**MINUTES
EAST NOTTINGHAM TOWNSHIP
BOARD OF SUPERVISORS
REGULAR MEETING
JUNE 11, 2007**

The Regular Meeting of the Board of Supervisors of East Nottingham Township was held in the Township Building on June 11, 2007. Those present were: Vice-Chairman Michael P. Miller, Supervisor Percy Reynolds, Supervisor Gene Turns, Treasurer Suzie Hamlin, Secretary Pat Brady , Zoning Officer P.J. Scheese and numerous guests. Chairman Leo M. Levandowski and Supervisor Charles D. Shelton did not attend.

The Meeting was called to order at 7:00 P.M..

The Pledge of Allegiance was led by Vice-Chairman Miller.

Approve Agenda- Motion made by Supervisor Reynolds seconded by Supervisor Turns to approve the agenda as presented by the Secretary.

Public Comment on Agenda- None

Executive Sessions- Vice-Chairman Miller stated there was an Executive Session on May 30, 2007 with the BOS and Richard O'Brien from Keystone Municipal Services.

Minutes for Review- Vice-Chairman Miller stated that the Minutes are available for review and will be approved at the end of the Meeting.

Joe Scheese stated that the May 14, 2007 Minutes do not mention the Sewer Authority report . Vice-Chairman Miller asked the Secretary to make a note of this and to check on it.

Treasurer's Report- Suzie Hamlin gave the report stating that East Nottingham Township's cash assets amount to \$3,137,193.63. Bills for 5/14/07 totaling \$96,507.03 were presented for payment from the General Fund. Income received for May totals \$283,345.44 realized from taxes, escrow, court fines, permits, inspection fees, fire hydrant reimbursement and miscellaneous fees. General Fund balance as of 5/31/07 is \$249,035.64.

Suzie Hamlin stated the Township received an audit from S.E.C.C.R.A. It is their report and she will put the audit on file.

Road Report- Vice- Chairman Miller stated there are copies of the Road Report in the back for viewing.

Supervisor Turns stated he received a report on the red light. It will be started the end of this week and finished next week by the 18th. Complete with poles and black top. They were held up on a big job.

Zoning Report- P.J. Scheese gave her report.. Vice-Chairman Miller asked what the Commercial Permit was for. P.J.Scheese responded it was for the Karate Studio in the J & B Market building.

Building Inspector Report- P.J. Scheese stated the Supervisors were going to talk to Rich O'Brien concerning a monthly report. Supervisor Turns stated there is a meeting next week with Richard O'Brien, the BOS and our Solicitor.

Police Study Committee Report- Bill Rodstein stated the Committee is still working under the BOS supervision and there is nothing further to report.

Comprehensive Plan Committee Report- Joe Bauer stated the Comprehensive Plan is in the works. The Supervisors have the next step.

Supervisor Reynolds stated the CCPC asked each Municipality to go back and talk with the Supervisors to see if they would consider entering into a multi municipal cooperative planning agreement. If the ENT BOS agree, then one Supervisor and one PC member will be appointed to serve on that Board. Then the Committee will start on a work plan. It will take approximately 2 years to have a finalized Plan. The cost to ENT will be approximately \$1,500. at the end of the Plan, which is 90% funded by CCPC. They will support us totally.

Motion made by Supervisor Reynolds seconded by Supervisor Turns to send a letter to the CCPC to move forward with the multi municipal planning. Supervisor Reynolds stated that Chairman Levandowski and Supervisor Shelton are fully aware of the information given at the Meeting tonight.

Oxford Area Recreation Authority Report- Joe Bauer stated they are getting ready to request for a proposal for Engineering on Parcel A Phase 1 for driveways, parking lots, baseball fields and an all purpose field for the site where the Fair will be held. The Fair plans are moving along. They have received Penn Dot approval for a second entrance by the big tree for the vendors to use.

Oxford Area Sewer Authority Report- Joe Scheese gave his report. The Act 537 Plan

Open Space Committee Report- Courtney Peterson gave the report. The properties which are being recommended to the Board are Alan Pugh, Blank, Esh and Wiley, totaling 208 acres. The Committee is trying to have the applicants also apply to the County.
