The Regular Meeting of the Board of Supervisors of East Nottingham Township was held in the Township Building on June 9, 2008. Those present were: Vice Chairman Michael P. Miller, Supervisor Percy Reynolds, Supervisor Gene Turns, Supervisor Charles D. Shelton, Treasurer Suzanne Hamlin, Zoning Officer P.J. Scheese, Secretary Pat Brady and guests. Chairman Leo M. Levandowski will be arriving shortly.

The Meeting was called to order at 7:00 P.M..

The Pledge of Allegiance was led by Vice Chairman Miller.

Treasurer's Report- Suzie Hamlin gave her report stating that East Nottingham's cash assets amount to \$5,349,614.61. Bills for May totaling \$63,230.53 were presented for payment from the General Fund. Income received for May 2008 totals \$236,342.28 realized from taxes, escrow, court fines, permits, inspection fees, fire hydrant reimbursement and miscellaneous fees. General Fund balance as of 5/31/08 is \$168,604.72.

Road Report- Road Master Bill Weaver stated everything is on the Report. They have been very busy with the roads. Painting on the roads will start shortly.

Zoning Report- P.J. gave her report. To date, she has registered 88 contractors. P.J. read a letter from the Oxford Band Parents Association requesting the fees be waived for a permit for a band directors stand in the amount of \$79.00. Tim Durham offered to donate all of his time. Charlie Shock is taking a class on swimming pools this month. P.J. would like to hold off on the blow up pools to determine if they need permits or not until Charlie takes the class.
