Because of the Township's Zoning Ordinance, both a Conditional Use Hearing and a Zoning Hearing Board are required. He just wanted a general idea as to what the Board thought about this, before he goes to that expense. There was some discussion regarding the problems with people dumping at the previous site.

Someone asked if he had considered putting on the West Nottingham side of the daycare property. He said the location the daycare requested is in ENT. Someone also asked if he had any shelters in West Nottingham and if so how much did it cost him in Township expense. He said yes he has a shelter there and that the permit cost him \$30. The Board suggested it might be cheaper to put it up on the WNT side, but that there were no objections to him putting one up in ENT.

Supervisor Dave Shelton informed the Board that Mrs. Wyatt, owner of the home that burned down last December would be coming in for the necessary permits to rebuild. The Board agreed to help Mrs. Wyatt to expedite this process wherever possible.
