MINUTES EAST NOTTINGHAM TOWNSHIP BOARD OF SUPERVISORS REGULAR MEETING JULY 12, 2010

The Regular Meeting of the Board of Supervisors of East Nottingham Township was held in the Township Building on July 12, 2010. Those present were: Chairman Leo Levandowski, Vice-Chairman Percy Reynolds, Supervisors Charles D. Shelton, Gene Turns, and John P. Coldiron, Zoning Officer P.J. Scheese, Township Treasurer Suzie Hamlin and guests.

The Meeting was called to order at 7:02 P.M.

The Pledge of Allegiance was led by Vice-Chairman Reynolds.

Changes made to the agenda were to move the first three items under "Supervisors" up to occur after "Public Comment on Agenda." Those items were:

- 2. Doug Fasick- water problem
- 3. Jerry Nelson, Bonnie Walleigh & Larry Krauss-Bethany Church/School Then to add after that "Carolyn Fleming, traffic signs within Twin Ponds."

Approve Agenda- A motion was made by Supervisor Vice-Chairman Reynolds, seconded by Supervisor Turns, to approve the agenda as amended. The motion carried

There was no public comment on the amended agenda.

Michael Kelly, Greenhouse Road

Michael, and his wife Kelly, came to the meeting with a petition signed by 19 people to request the Board about getting Verizon to install its service on Greenhouse Road. There was some discussion. At the end of it Chairman Levandowski said he would discuss this with Township Solicitor Alan Novak. PJ Scheese was directed to scan the petition and send it in an email to Mr. Novak, with a copy to Supervisor Levandowski, who will speak with him about Verizon.

Jerry Nelson, Bonnie Walleigh & Larry Krauss - Bethany Church/School

These residents came to the Township to see if anything could be done about the adult softball league that uses the school's field. Issues, such as litter, noise, and softballs landing in neighboring yards have existed for the past 3 years. There was some discussion about this. In the end Suzie Hamlin stated that Bethany no longer allows the adult leagues to use that field. A letter is to be written to Bethany confirming that this is the case.

Carolyn Fleming - Traffic signs in Twin Ponds

Ms. Fleming is on the TP Homeowners' Association and said she has their support (although no one wants to take a stand) in requesting speed limit signs being put up in Twin Ponds. She would like to see the speed limit reduced to from 25 MPH to 15 MPH. The Board informed her that this was not a simple task and then did not feel it was necessary. Roadmaster, Bill Weaver was instructed to put speed limit signs up at each entrance. Mr. Weaver said this would be done by the first of next week. He is also to look into putting up bus stop signs as well. Ms. Fleming is to email the neighborhood to let them know the signs are coming.

Doug Fasick - Water Issues at Autumn Hill

Dr. Fasick has been working with the Board and some of his neighbors on the ongoing water problems in parts of Autumn Hill. He told the Board that Wayne Megill is checking with Terrance Farrell, County Commissioner and State Senator Dominic Pileggi's office to see if they can get some help there. Dr. Fasick wants to know the language regarding the easements on some of the properties. The estimate he was given to fix this problem is \$52,000. He wants to know if the easements can be extended to other properties. Supervisor Shelton said that Township Engineer Ron Ragan should be involved in this discussion. Supervisor Coldiron is to set up a meeting and tell Supervisor Shelton, who will ask Ron Ragan to attend.

Comprehensive Plan Report

Supervisor Reynolds stated that there was no meeting last month.

Oxford Area Rec Authority Report

Joe Bauer said that things are coming along slowly. The received an extension from the county to the end of December for the grant. The site should be complete by August 31st of this year. The inspection walk through by the OARA should begin in September. The contractor should have all problems corrected by the end of September. They received a Natural Land Trust Grant from PECO in the amount of \$5000, which will finish the trail around the park.

There is still some finish grading to be done. Mr. Bauer said that he is trying to get some money from the county. Currently they have \$500 in their account and over \$60,000 of unpaid bills.

The audit should be done by the end of July. The General contractor and administrator are about 10% over budget. There were 3 change orders totaling about \$28,000. They are approximately \$130,000 over what was anticipated at this point, and he expects they will end up being around \$250,000 over the original cost anticipated, which was \$500,000.

Perimeter security will consist of posts in the ground with a cable through it.

Oxford Area Sewer Authority Report

Joe Scheese told the Board that they have completed the presentations of the Act 537 Plan to all the participating municipalities' planning commissions. Lower Oxford Township's PC approved it at their last meeting. The comment period for the Plan ends the second week of July. Everything looks good.

They don't know when they will be getting the loan money. Although the Plan and the loan are not tied together, they are not allowed to spend any of the loan money until the 537 Plan is in place.

Open Space Committee Report

Supervisor Shelton wants to invite the Open Space Committee and the Planning Commission to attend the next TDR public meeting. He has personally invited Joe Bauer. Chairman Levandowski said he wants the Brandywine Conservancy to look at all possibilities, including the residential use of TDR for Planned Village Commercial Centers.

Historic Commission Report

Kenny Knapp passed away. PJ Scheese was instructed to contact Ralph Denlinger about Kenny's display in the meeting room at the township building, to find out if it was donated or if it might need to be returned to his family.

At this time Ed Jefferis, of Concord Land Planners, asked the Board's indulgence to grant a request concerning the Fire Company. They will be submitting a Land Development plan at some point. However, before they do that they request they be able to contact Township Engineer Jim Gade to review what they are working on with Penn Dot. The cost will be rolled into the cost of the LDP when it is submitted. The Board agreed to allow this.

Township Matching Funds for the Chester County Challenge Grant Program

Employee Benefit Specialists

Treasurer Suzie Hamlin recommended to the Board the Township change its health insurance broker. She researched references for Employee Benefit Specialists and believes they take a more personal approach. The premium will remain basically the same, though there are some things to look into that could possibly lower costs. The current broker, Taylor and Ochroch, requires 60 days notice of cancellation with them. Two things must be done. First an "Agent of Record" letter must be signed. Second ENT must authorize Employee Benefit Specialists access to its Blue Cross IBX.com account.

A motion was made to accept the proposal from EBS for employee benefits. The motion carried.

Township Generator

Supervisor Turns reminded the Board of the loss of electricity to the township a couple of weeks ago, and raised the issue of purchasing a generator to keep the office and the garage doors operational when this happens. Supervisor Shelton stated that he wants a professional to come to the township to make a presentation. Roadmaster Bill Weaver said they would need at least 100 amps. Supervisor Coldiron said that no more than 22 kw was necessary. Supervisor Turns will continue to work on this.

Stop signs at Little Elk Creek Road and Fifth Street

Supervisor Turns said that we need stop signs on Fifth Street at this intersection. In previous conversations Ron Ragan had stated that it would cost between \$1200 and \$1500 for a study.

A motion was made by Supervisor Shelton, seconded by Gene Turns, to have Ron Ragan to a traffic study for that location. The motion carried.

Joe Scheese said that the railroad tracks on both Twin House Road and Waterway Road need to be fixed. Supervisor Reynolds said he will talk to East Penn Railroad on Friday.

Supervisor Coldiron asked if anyone is trying to figure out what electrical service the Township is going to use for 2011. Supervisor Levandowski thinks it is a little early to look at that. Joe Scheese said that the OASA joined a consortium to get a really good rate. Suzie Hamlin said she will talk with Ed Lennex to see what they did and check to see if it is also an option for a township.
