HEARING ON TAX REFERENDUM ORDINANCE
JULY 14, 2015

The Board of Supervisors of East Nottingham Township held a hearing on the adoption of an ordinance to place a referendum question on the November ballot to retain or repeal the Earned Income Tax for open space. The hearing was held in the Township Building on July 14, 2015 at 7:00 p.m. The purpose of the hearing was to present the proposed ordinance to establish a referendum question to be placed on the ballot for November, 2015 concerning the continued imposition of the Earned Income Tax for the purpose of acquiring interests in open space. Those present were: Chairman Scott Blum, Vice Chairman Art Rieck, Supervisor John P. Coldiron, Supervisor Jane Ladley, Supervisor Joe Raffa, Zoning Officer P.J. Scheese, Secretary Pat Brady, Township Treasurer Suzanne Hamlin and Winifred Sebastian, Solicitor and members of the public.

The hearing was called to order at 7:00 p.m. by the Chairman. The hearing was immediately recessed for purposes of opening the work session and regular meeting of the Board of Supervisors which were then recessed. The Chairman then reopened the hearing and turned the hearing over to Winifred Sebastian, Solicitor.

The Solicitor placed into the record the Proof of Publication of the advertising of the hearing in the Daily Local News and the Chester County Law Reporter. She then described the ordinance provisions which specifically establish a referendum question to be placed on the ballot for November, 2015 concerning the continued imposition of the Earned Income Tax for the purpose of acquiring interests in open space.

After the ordinance was described, information concerning the funds currently available from the tax as well as expenditures from the funds were presented by the Treasurer. The hearing was then opened for public comment on the ordinance.






