

**MINUTES

SPECIAL MEETING
SEPTEMBER 20, 2017**

The Special Meeting of the East Nottingham Township Board of Supervisors was held in the Township Building on September 20, 2017. Those present were Chairman Art Rieck, Vice Chair Shelley Meadowcroft, Supervisor Joe Herlihy, Supervisor Sam Goodley, Supervisor Gary Coates, Treasurer Suzanne Hamlin, Zoning Officer PJ Scheese, Secretary Pat Brady and guests.
