#### Robert Mills Subdivision Plan

This subdivision is actually two tax parcels combined into a single lot on a single deed. One tax parcel is located in West Nottingham Township and one is located in East Nottingham Township. The parcel in ENT has no structures on it. Ed Jefferis, of Concord Land Planners, was present to represent the applicant. Several Waivers have been requested from SALDO Sections:

22-302.B & 22-304.4 - In the definition of a Minor Subdivision Plan it states in section 22-301.A(1)(g) that to qualify as a minor plan the "subdivision is not in a floodplain." The applicant is requesting a waiver from having to submit separate preliminary and final plans, and rather submit a single plan for both. A motion was made by John Wallace, seconded by Janice Gavin, to recommend to the BOS to approve this waiver request. The motion carried.
